Open Access Policy

Introduction

The Institute for Advanced Study (IAS), as one of the world's leading centers for curiosity-driven research, is committed to ensuring access for all people who wish to learn, benefit from or build on the scholarship conducted at the Institute. It is also recognized that by disseminating scholarship to a wider audience, the Institute and its affiliated scholars enjoy many additional benefits, including the reservation of rights as it pertains to publishing agreements, a broader and more critical review of their work, improved findability and recognition, a commitment to preservation, and a more knowledgeable and informed public.

Scholarly work is herewith understood as, but not limited to, books, articles, datasets, working papers, pre-publication scholarship, and published papers. With this in mind, IAS has established an institutional open access digital repository known as Albert that can be found online at albert.ias.edu.

Policy

Grant of License

Each person with the rank of permanent Faculty or professor Emerita(us) shall grant to the Institute for Advanced Study a nonexclusive, irrevocable, worldwide license to each of his or her scholarly works. This license entitles IAS to exercise any and all copyrights in any medium, whether known or later invented, for the purpose of making the material(s) available in an open access digital repository, under the CC BY license.

All other scholars such as, but not limited to, Long-term Members and Visitors, Research Associates, Senior Research Associates, and those who are eligible for membership in the Association of Members of IAS (AMIAS) may grant to the Institute for Advanced Study a nonexclusive, irrevocable, worldwide license to each of his or her scholarly works. This license entitles IAS to exercise any and all copyrights in any medium, whether known or later invented, for the purpose of making the material(s) available in an open access digital repository, under the Creative Commons CC BY license.

Scope

This grant applies to all scholarly works authored or co-authored while appointed to IAS, with the exception of materials published prior to the date of the adoption of this policy. This grant does not transfer ownership of copyright, which remains with the author(s), as described in Section 4 of the Institute's Intellectual Property Policy and Procedures (available online at: https://www.ias.edu/human-resources-policies-and-procedures).

Waiver and Addendum

IAS encourages publications in other open access journals and platforms. Upon request, an author may waive the grant of licensure for an individual article, or request a delay in its publication to the repository, for a specified period of time. This waiver request may be submitted online, at https://www.ias.edu/open-access/waiver. In addition, to best reserve rights and avoid contractual conflicts, it is recommended that authors attach the IAS Author Addendum to their agreements negotiated with publishers. Authored specifically to address the prior license granted to IAS, this addendum is available online at https://www.ias.edu/open-access/author-addendum.

Submission of Copy

Scholars subject to this policy, not permanently waiving their license grant, are encouraged to upload an electronic copy of their work(s) for inclusion in Albert. If the work is an article, it should be uploaded in final manuscript form.

Beyond the above, this policy in no way attempts to prescribe or limit the publication venue chosen by the author(s).

Interpretation

The sitting Executive Officers, with the support of the Faculty Committee on Information Technology and the Digital Scholarship Working Group as necessary, will be responsible for interpreting this policy and resolving any disputes which may arise from its application. IAS will also endeavor to develop a mechanism that would allow scholars a convenient method for complying with this policy, which will further be regularly monitored for its effectiveness.
